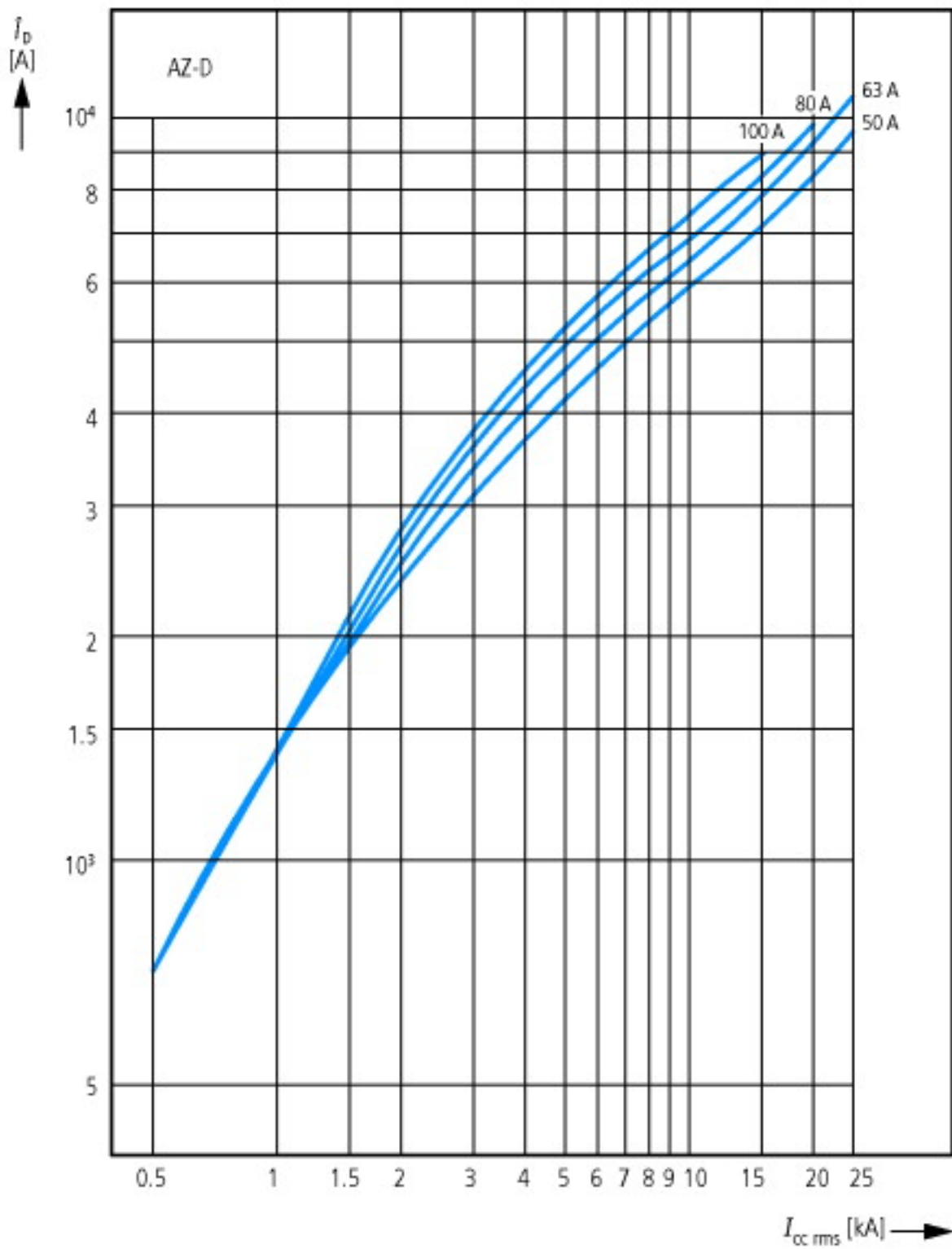


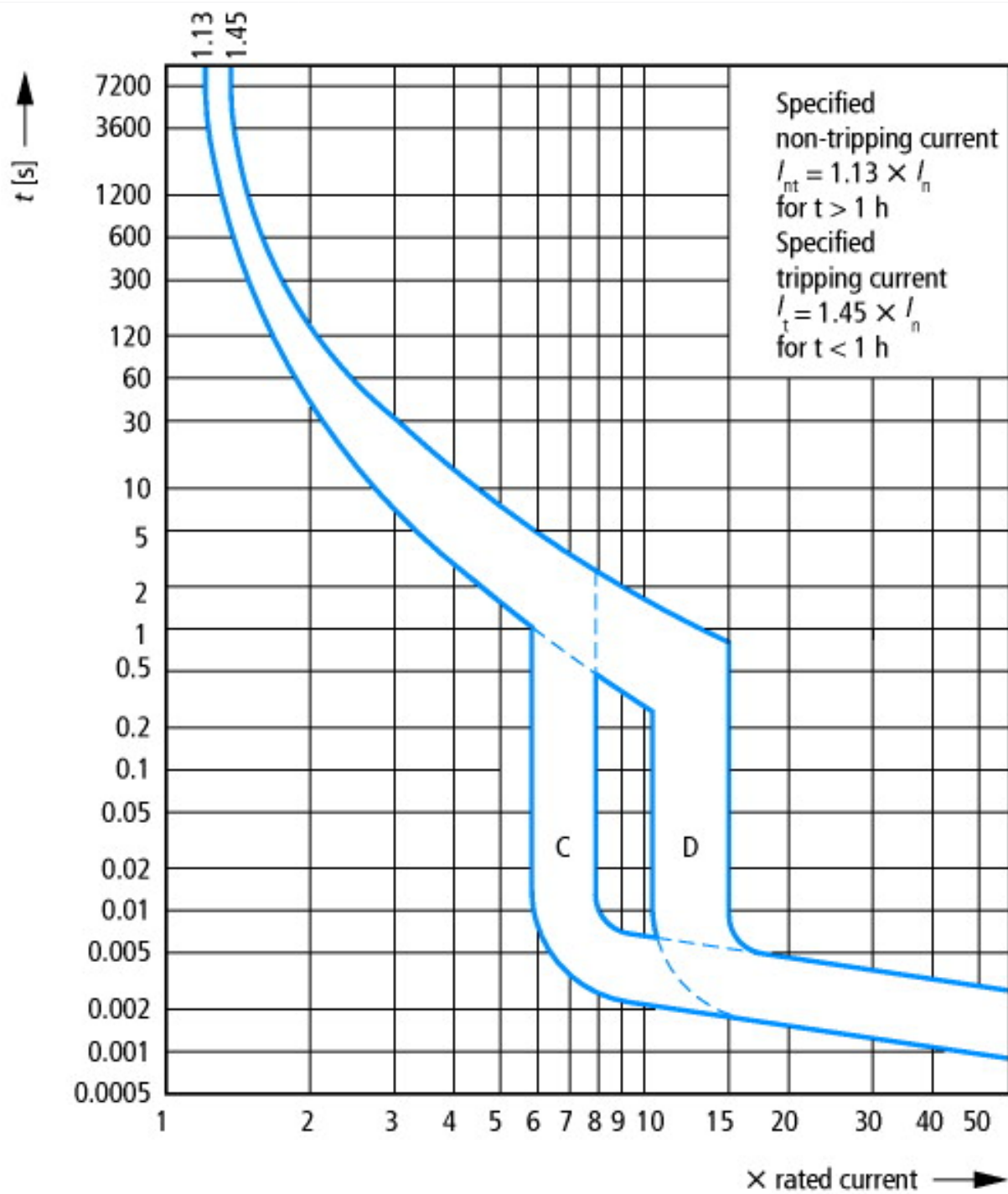
Let-through energy I^2t



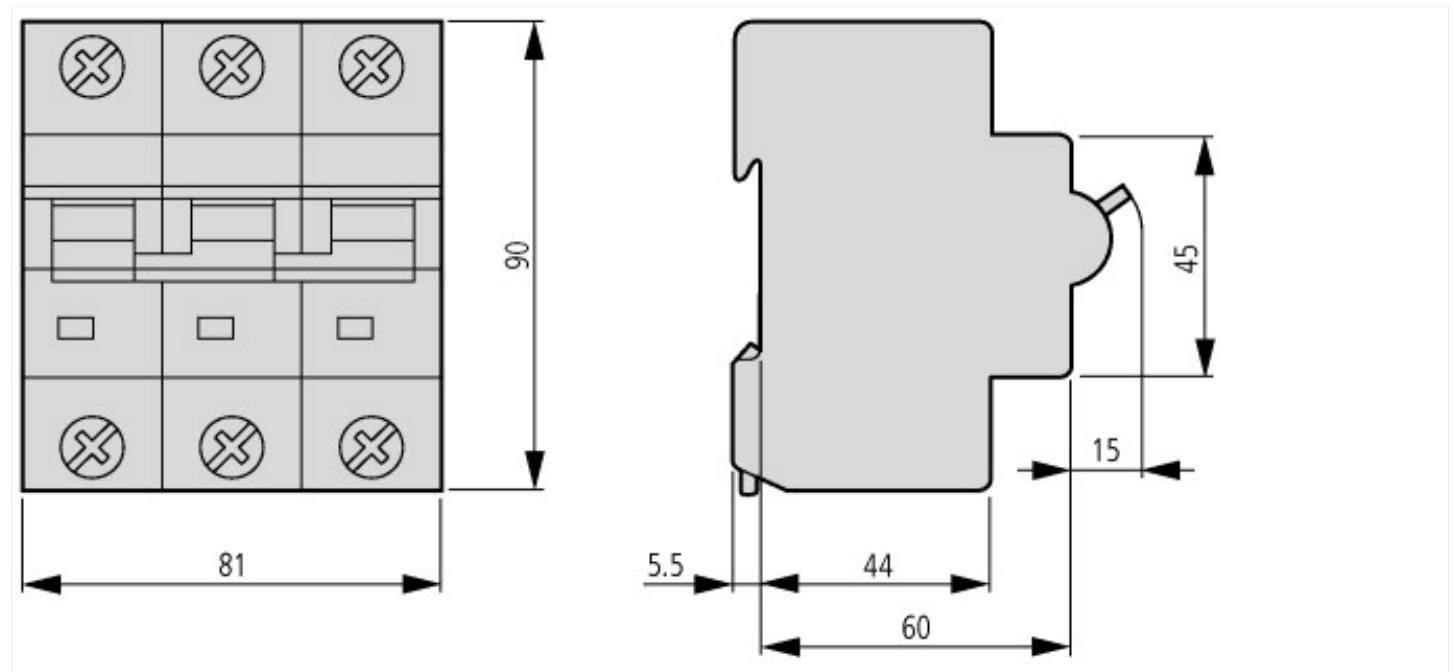


Let-through current i_D
